Before you invest in any fund, consider how the fund would work with your other investments and your tolerance for risks.

This mutual fund is an alternative mutual fund. It is permitted to invest in asset classes or use investment strategies that are not permitted for other types of mutual funds. The specific strategies that differentiate this fund from other types of mutual funds include: increased use of derivatives for hedging and non-hedging purposes; increased ability to sell securities short; and the ability to borrow cash to use for investment purposes. While these strategies will be used in accordance with the fund's investment objectives and strategies, during certain market conditions they may accelerate the pace at which your investment decreases in value.

What does the fund invest in?

The investment objective of the fund is to provide unitholders with a total return (i) in the form of income and long-term capital appreciation, and (ii) that will generally move differently from returns of traditional equity and fixed income securities markets. The fund primarily invests in alternative mutual funds and the asset of the fund is primarily exposed to fixed income securities or others credit related products.

The fund may employ leverage, mainly through the underlying funds, which includes the use of derivatives, short selling and/or cash borrowing, up to an aggregate exposure limit of 300% of its net asset value, borrow cash up to 50% of its net asset value for investment purposes or to pay for the redemption of redeemable units by holders, and short selling securities short up to 50% of its net asset value (the combined level of cash borrowing and short selling is limited to 50% in aggregate).

How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

RGP Investments has rated the volatility of this fund as Low to medium.

Because this is a new fund, the risk rating is only an estimate by RGP Investments. Generally, the rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

 You are prepared to accept low to medium risk; You are looking for a medium-term to long-term investment; and You are looking for a managed investment solution focused on income generation while aiming for long-term capital appreciation. 	In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account. Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.			



How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell class I units of the fund. The fees and expenses, including commissions, can vary among classes of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

You pay no sales or redemption charges when you buy, redeem or switch class I units of the fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the returns of the fund.

The fund's expenses are made up of the management fee, operating expenses and trading costs. The negotiated management fees paid directly to RGP Investments shall not exceed the management fees charged for class F units of the fund, that is 1.00%. The negotiated administration fees paid directly to RGP Investments shall not exceed the administration fees charged for class F units of the fund, that is 0.24%. Because this class is new, operating expenses and trading costs are not yet available.

More about the trailing commission

There is no trailing commission for class I units of the fund.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the fund. Class I units are only offered to investors who have received RGP Investments' prior authorization. Class I units are not offered to the public.

Switch Fee	There are no charges if you switch or transfer your units.		
Short-term Trading FeeUp to 2% of the amount that you redeem or switch if you buy or switch and then redeem or switch of fund within 90 days of purchasing or switching them. This penalty will be paid directly to the fund.			
Class I Units Management Fees	Each investor negotiates and pays directly to RGP Investments management fees on class I units. As a result, the management fees are not included in the fund's management expense ratio. The negotiated management fees paid directly to RGP Investments shall not exceed the management fees charged for class F units of the fund, that is 1.0%.		
Class I Units Administration Fees	Each investor negotiates and pays directly to RGP Investments administration fees on class I units. As a result, the management fees are not included in the fund's management expense ratio. The negotiated administration fees paid directly to RGP Investments shall not exceed the administration fees charged for class F units of the fund, that is 0.24%.		
Additional Services	Your representative's firm may charge a fee for additional services. Certain of these fees are negotiable while others may not be. Such fees are not paid to RGP Investments. For example, a fee may be charged to you for each cash distribution you request by cheque (such fee being generally not negotiable). You may also have to pay transaction fees if you own an account with a discount broker.
