### How risky is it?

The value of the fund can go down as well as up. You could lose money. One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility". In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater change less over time. They typically tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### **Risk Rating**

RGP Investments has rated the volatility of this fund as **Medium to High**.

Because this is a new fund, the risk rating is only an estimate by RGP Investments. Generally, the rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

#### No quarantees

Like most mutual funds, this fund does not have any guarantees. You may not get back the amount of money you invest.

### How has the fund performed?

#### Who is this fund for?

- You seek long-term growth appreciation;
- You are comfortable with medium to high investment risk (i.e., you are willing to accept fluctuations in the market value of your investment that may be above that of broad equity market indices);
- You want a fund that has an exposure to global markets; and
- You are comfortable with a fund investing in a limited number of securities.

#### A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan, or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.



#### How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell class A units of the fund. The fees and expenses – including any commissions – can vary among classes of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

### 1. Sales charges

The class A units are offered on a front-end basis. This means that you may pay a sales commission of up to 5% of the value of your investment to your representative's firm when you purchase class A units.

#### 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of December 31, 2024, the fund's expenses were 2.93% of its value. This equals \$29.30 for every \$1,000 invested.

## More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you.

RGP Investments pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate depends on the sales charge option you choose.

The rate for the class A units of the fund is 1% of the value of your investment each year. This equals to \$10 each year for every \$1,000 invested.

## 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

Switch Fee	Your representative's firm may charge you a fee of up to 2% of the value of your units for its services. You must negotiate this fee with your representative's firm. Such fees are not paid to RGP Investments.
Short-term Trading	Up to 2% of the amount that you redeem or switch if you buy or switch and then redeem or switch class A units of
Fee	the fund within 90 days of purchasing or switching them. This penalty will be paid directly to the fund.
Additional Services	Your representative's firm may charge a fee for additional services. Certain of these fees are negotiable while others may not be. Such fees are not paid to RGP Investments. For example, a fee may be charged to you for each cash distribution you request by cheque (such fee being generally not negotiable). You may also have to pay transaction fees if you have an account with a broker offering a discount brokerage service.





# What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or a fund facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, fund facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
