# **Results of Operations**

The Fund's Class "A" returned 6.6%, after deducting fees and expenses, for the period from January 1<sup>st</sup>, 2025, to June 30, 2025. The net returns of the other classes of this Fund are similar to those of Class "A", except for differences attributable to the fee structures specific to these classes. For the performance of the various classes and the Fund's long-term performance, please refer to the "Past Performance" section of this report.

The Fund's benchmark returned 5.8% for the reporting period. It is composed of 12% S&P/TSX Capped Composite Index, 41% S&P500 Index in Canadian currency, 27% EAFE Index in Canadian currency, 8% S&P Canada Aggregate Bond Index, 2% S&P Canada Investment Grade Corporate Bond Index, 3% of the Bloomberg Barclays Global Aggregate Index in Canadian currency, 3% of the Bloomberg Barclays Global Aggregate Index in local currency and 4% of the Bloomberg Barclays Global Corporate Index in local currency. As a result, the Fund slightly outperformed its benchmark. Unlike the indices, the Fund's performance is determined after deduction of fees and expenses. In addition to these fees, other factors also influenced the Fund's performance.

Being mainly invested in equities, the Fund took advantage of the strong stock market recovery in Q2 2025, offsetting the declines that occurred earlier in the year. Despite periods of high volatility, the manager made no significant changes to the Fund, with the exception of a 4% reallocation from fixed income to equities during the March-April market correction. The managers maintained their sector targets close to equal weighting. Among the notable movements in the Fund, the communications sector saw its weighting increase, while the allocation to the technology sector decreased. The disparity in sector returns is the main reason for these variations.

At the close of the reporting period, the U.S., Canadian, and developed Europe and Asia stock indices had gained 0.6%, 10.2% and 13.3% respectively over six months, when reported in Canadian dollars. As the Fund's geographic allocations were similar to those of the index over the period, the performance gap between the various markets did not significantly affect the Fund. The general weakness of the U.S. dollar reduced returns on U.S. equities, when reported in Canadian dollars. In Canadian bonds, government bonds returned 1.2% over the period, compared with 2.3% for corporate bonds. The Fund therefore benefited from its underweight in government fixed-income securities.

Through its selection of underlying funds, the Fund benefited from the marked rise in gold mining company stocks, supported by the 25% rise in the price of gold, in U.S. dollar terms, during the half-year. However, the Fund suffered from a sharp drop in its exposure to healthcare companies held in the portfolio.

The net asset value of the Fund's assets increased by \$5.6 million during the period, ending at \$89.6 million at June 30, 2025. This change is mainly attributable to investment performance, with net securityholder transactions having little impact on the period.

# **Recent Developments**

Geopolitical and economic risks created a great deal of uncertainty during the period, but markets continued to prove more resilient than anticipated in the context. The new U.S. administration's intentions to increase trade tariffs led to a pronounced downturn in equity markets and in the Fund at mid semester, although concerns later subsided.

The final level of tariffs set by the U.S. government remains uncertain, and their impact on international trade, production costs, international sales and consumer prices, remains to be seen. Internal political divisions and ambiguity in communications from the White House seem to have pushed investors to look for opportunities outside the U.S. The introduction of a new U.S. budget bill, which would extend Trump's 2017 tax cuts, could increase debt levels and reignite inflationary pressures in the future. Currency prices and risk premiums on long-term bonds could yet experience more volatile months than normal. Nevertheless, the fiscal deficits incurred by the governments of several developed countries appear to be supporting corporate profits and economic growth, encouraging a gradual return to an equity-neutral asset allocation in the Fund. The high valuations of the companies weighing most heavily on the index could reverse and return closer to their historical averages, which would be favourable to the Fund's strategy, as it holds fewer of these stocks. Nevertheless, future events and their influence on markets always remain uncertain.

On March 20, 2025, Mr. Gilles Lemieux and Mr. Pierre Rousseau were appointed Chairman and member of the Independent Review Committee, respectively, following the end of Mr. Michel Desjardins' mandate.

# **Related Party Transactions**

#### Manager, Trustee and Portfolio Advisor

R.E.G.A.R. Investment Management Inc. is the Manager, Trustee and Portfolio Advisor of the Fund. The Fund pays management fees to the Manager and Portfolio Advisor in return for management and investment advisory services (see the Management Fees section below). For the period ended June 30, 2025, total management fees were \$660,768. The Fund also pays administration fees to the Manager. In return, the Manager assumes responsibility for the Fund's operating costs and expenses, apart from certain specified costs. For the period ended June 30, 2025, total administration fees were \$117,350.

The Fund paid distributors a service fee for the direct or indirect provision of services to the Fund. See the Information on Classes section for the annual expense rates for each class (as a percentage of average net assets). Holders of Class F units also pay consulting fees directly to the office of the authorized distributor. Holders of Class P units pay fees for consulting services directly to the manager. These fees are not part of the Fund's expenses.

#### **Other Related Party Transactions**

During the period and pursuant to applicable securities legislation, the Fund relied on a standing instruction from the IRC in connection with inter-fund transactions, where securities may be sold to, or purchased from, another fund managed by the manager. Under the IRC's standing instructions, the manager must act, for each of these transactions, in accordance with related policies and procedures and applicable law. Additionally, the standing instructions require that investment decisions related to these transactions be made at market prices and aim to reduce the transaction fees and commissions incurred by the Funds.

#### Holdings of Class I units of the RGP Global Infrastructure Fund

The Fund holds Class I units of the RGP Global Infrastructure Fund, another fund manager by the Manager. As at June 30, 2025, the Fund held 509,549 Class I units, representing 47.08% of outstanding units of the class.

## **Management Fees**

The Fund pays management fees to R.E.G.A.R. Investment Management Inc. The management fee paid per class is calculated as a percentage of the net asset value of the class as of the close of business on each business day (see "Information on Classes" below for management fees paid by each Class, as well as the breakdown of the services received in return, as a percentage of management fees). The management fees are used in part to pay costs incurred for investment advice and for investment management services, as well as for services related to distribution, including the cost of financial planning services, advisor commissions and bonuses, costs related to marketing and other promotional activities and Fund training sessions.


