# **Fund Investment Objectives**


The investment objective of this Fund is to generate regular income by investing primarily in Canadian investment grade fixed-income securities. To achieve this objective, the Fund invests in securities directly, or indirectly through ETFs and underlying mutual funds, using a responsible investing approach. The Fund may invest in low-quality fixed-income securities, also known as high-yield securities (rated less than BBB by Standard & Poor's Rating Services (Canada) or an equivalent rating from one or more designated rating agencies), as well as in instruments similar to debt securities, up to a maximum of 20% of its net assets. The Fund may invest in emerging countries securities, up to a maximum of 10%. The total combined percentage of low-quality fixed-income securities, also known as high-yield securities, and emerging countries securities may not exceed 30% of the net assets of the Fund.
